Finance

The Executive Committee was informed that the Secretariat has been the victim of fraud. In January 2016, the 1st 2016 quarter rent money (roughly 16.000 EUR) has been intercepted and payed to a "fake" bank account. The Secretariat reported to the police and the state attorney. So far, the bank has not provided any explanation. CPME's primary objective is to recuperate the payement. To this end, the EC members commissioned the CPME Secretary General to seek legal advice on how to deal with the bank. Should these efforts not be succesfull and in case the money is not transferred back to CPME, the amount should not be depreciated but marked as a loss.

Internal affairs

The Executive Committee concluded on the discussions regarding possible changes to the CPME Statutes and Rules of Procedures. In preparation of the discussions at the upcoming General Assembly in Tel Aviv, the Secretariat will circulate the final draft documents as submitted by the Executive Committee on behalf of the Board to CPME members by mid-August 2016..

Policies

Diet, nutrition, physical activity

The Executive Committee approved the draft terms of reference for a CPME Working Group on Diet, Nutrition and Physical Activity, as well as a draft to launch the working group's discussion on obesity. The Executive Committee also proposed to invite the working group to address the socio-economic determinants of health in the policy paper. It is planned to present a policy paper to the CPME Board for decision in November 2016. In April 2016 the Board had decided to create such a working group to support CPME Rapporteur Prof Rutger Jan van der Gaag in the drafting of a policy on obesity, which should i. a. discuss the possible recognition of obesity as a disease.

The Executive Committee approved the <u>CPME draft position</u> the proposal to amend the <u>Audio-Visual</u> <u>Media Services Directive</u>. The Directive coordinates national laws on audio-visual media services, i.e. television and on-demand services, and governs commercial communications and restrictions to advertising. The EC reviewed the <u>proposal</u> and agreed that it is useful to repeat the positions CPME adopted in the response to the consultation on the Directive in 2015 as regards the need to introduce legislation controlling advertising of unhealthy foods and alcohol.

Professional qualifications

The Executive Committee approved the <u>draft CPME response</u> to the European Commission's <u>consultation</u> on the regulation of professions, Member States' National Action Plans and proportionality in regulation. The consultation builds on the outcomes of the mutual evaluation and transparency exercise of the regulation of professions introduced by the amendment to the Professional Qualifications Directive. The EC members discussed the importance of reaffirming the principles of professional regulation established in CPME policies, as well as encouraging the membership to review the national action plan and respond to the consultation.

European semester

The Executive Committe was presented the CPME briefing on the European Semester and welcomed it as a basis for further CPME discussions. This document presents background information on the European Semester process, the current country-specific recommendations and the opportunities and rationale for CPME members to become involved in the process. The format of the CPME briefing is to offer members a new service by combining detailed information and tools for action on issues of high political interest. Please find the briefing at CPME 2016/076.

International calendar

The Executive Committee reviewed the CPME participation at forthcoming meetings of CPME members, European Medical Organisations and international partners.

Any other business

The Executive Committee was informed that Prof. Dr Reinhard Marre, CPME's representative to the <u>Advisory Forum of the European Centre for Disease Prevention and Control (ECDC)</u> has announced his intention to resign from the position. He has offered his assistance in the process of nominating a candidate to replace him. Prof. Marre will be invited to the CPME meetings in November 2016 to bid him farewell.

In addition, the Executive Committee agreed to distribute the <u>Web-RADR survey</u> on the reporting of adverse drug reactions via a mobile application to CPME members. However, the EC members specified that CPME involvement should be strictly limited to the distribution of the survey.

On September 12-13, the Patient Access Partnership (PACT) will hold its first Regional Conference entitled "Cooperation within the Region: A Way to Improve Access to Quality Healthcare in CEE". The event, which will take place in Sofia, will gather local representatives of the PACT partners from Central and Eastern European countries, including Serbia and Turkey. Public consultation on EU guidelines on prudent use of antimicrobials in human medicine

In the context of ongoing work against the rising threats from antimicrobial resistance and given the role of antimicrobial misuse and overuse in the emergence and spread of resistance, the European Commission requested ECDC to develop draft **EU guidelines on the prudent use of antimicrobials in human medicine**. The draft guidelines, which will support the European Commission in its aim to produce the final EU guidelines on this topic, are now open for **public consultation** at the following link on the ECDC website: <u>http://bit.ly/ECDC antibiotic use</u>.

The deadline for the public consultation is **5 September 2016**. CPME will draft a response.

Public consultation on the European Pillar of Social Rights

The European Commission has launched a public consultation on the European Pillar of Social Rights. The focus is on the principles established in the Pillar on i.a. employment rights, equal opportunities and healthcare. The consultation will close on 31 December 2016. CPME will prepare a response.

Open consultation concerning surrogacy

The Council of Europe launched an open consultation concerning surrogacy until 31 August 2016.

Your response is likely to be valuable as a contribution to the opinion of the International NGOs Conference of the Council of Europe which is to be adopted in the 2nd half of 2016.

EPSCO Council conclusions and Polish note

The Employment, Social, Policy, Health and Consumer Affairs Council (EPSCO) is one of the thematic configurations of the Council of the European Union (the institution representing member states'). EPSCO meetings gather ministers responsible for health, employment, social policy and consumer affairs. There a four annual meetings, two of which concern employment and social policy and the other two which refer to health and consumer affairs.

Three main outcomes of the EPSCO meeting on 16 - 17 June 2016 are relevant for European doctors:

The Polish delegation submitted a note for discussion highlighting the dangers of European standardization of healthcare services, namely the CEN initiative that extended its mandate from technical standards to healthcare services. It reminded that article 168 TFEU clearly states that healthcare services are competence of the EU member states.

The following delegations supported the Polish position: Belgium, Bulgaria, Finland, Germany, Austria, Croatia, Lithuania, and Malta (please find the note here). Romania highlighted the difficulties of engaging with the European Committee for Standardisation (CEN) due to the high costs of participation.

The Member States also challenged the Commission as to its role in the process, referring i.a. to Commission events on standardisation and the Annual Work Programme for European standardisation which includes a chapter on healthcare services.

Council conclusions concerning next steps of the One Health approach to combat antimicrobial resistance (council conclusions are available here)

First of all, Member States are asked to have national action plans in place by mid-2017, which include notably measurable goals, mechanisms for implementation and monitoring as well as targeted campaigns to raise awareness among consumers, animal keepers and relevant professionals. In addition, Member States together with the European Commission should also develop an EU Action Plan on Antimicrobial Resistance considering the One Health approach.

Council conclusions on strengthening the balance of pharmaceutical systems in the EU and its member states (council conclusions are available <u>here</u>)

These conclusions aim at stimulating further cooperation on pricing and reimbursement of medicinal products. This cooperation should remain on a voluntary basis between Member states that share common interest.

In addition, further cooperation at the EU level is foreseen, namely within EUNEtHTA and the most relevant point refers to further investments at national and EU level in the development of innovative medicines for clearly defined unmet medical needs.
