Finance

Amendment to Statute Proposal

The Executive Committee took note of the “secondary” [amendment](#) by the Swedish Medical Association to the CPME Statute proposal circulated on 4 January 2019.

The proposal has been sent to the members on Friday 15 March 2019 for consideration next General Assembly on the 6th of April in Valletta (Malta).

Invitations to Past Presidents

The Executive Committee decided to invite the past presidents of the CPME to the future General Assemblies and Board meetings, as gesture of courtesy for having shaped the history of CPME during their mandates. However, any expenses will be on their own cost.

ThisTimeImVoting

The Executive Committee decided to join the European Campaign ThisTimeImVoting.

[Thistimeimvoting.eu](#) is a non-partisan community organised by the European Parliament, dedicated to raising democratic awareness. It follows the motto “it's not enough to hope for a better future: this time each and every one of us must take responsibility for it too.” In fact, the EU Parliament is asking Europeans not only to vote, but also to spread the word and to mobilise their families, friends, neighbours and communities to do so too.

The platform was launched by the European Parliament in 24 languages. It supports over one hundred and fifty thousand volunteers in all member states, who signed up and are committed to persuading people to vote in the European elections on 23-26 May 2019. The use of social media, organisation of local debates and events, production of promotional material, are some of the tools used to promote the campaign for European democracy.

CPME Secretariat is seeking advice on how and in which ways our organisation can join the campaign. Members will be informed as soon as possible.

Renewal of the EMA Healthcare Professionals Working Party (HCPWP)'s mandate

The Executive Committee agreed to pursue CPME's involvement in the EMA Healthcare Professionals Working Party ([HCPWP](#)) and, therefore, to renew its membership.

Regarding CPME's representation, Dr Christiaan Keijzer, as chair of CPME cluster on pharmaceuticals, will discuss practical aspects with Dr Erzsébet Podmaniczky, chair of the CPME [WG on pharmaceuticals](#).

Policies

Contraception Atlas

The Executive Committee decided to endorse the [White Paper "Limited Access: Europe's Contraception Deficit"](#). CPME's feedback on one of the ten recommendations of the White Paper is taken into account.

The 2019 Edition of the Contraception Atlas was launched in February, emphasising that access to contraception should be a key concern of governments in empowering citizens to plan their families and lives. Its findings show that for many European countries ensuring that people have choice over their reproductive lives is not a priority. The Atlas tracks government policies on access to contraceptive methods, family planning counseling and the provision of online information on contraception in 46 European countries.

The White Paper, established by the group of experts (CPME Immediate Past President Dr Jacques de Haller is expert for CPME) which is supported by the European Parliamentary Forum on Population and Development, contains the latest information taken from the Atlas and other relevant research and analyses access to contraception in Europe. It covers three areas: reimbursement of contraceptive supplies, access to family planning counselling and access to online information on modern contraception methods. The White Paper provides ten recommendations on how to improve access to contraception in Europe.

KDC survey on fees for disciplinary procedures

The Executive Committee approved the request of the Kosovo Doctors Chamber to circulate a survey on fees incurred in relation to disciplinary proceedings.*

The survey concerns fees levied by national medical associations from the complainant to initiate disciplinary proceedings against a doctor. The background to the request is a query from the national Ombudsman who is questioning the need for a fee, hence the interest in other national medical associations' policies on this. The EC requested further clarification of the type of proceedings this fee relates to for inclusion in the send-out to member. CPME Secretariat will coordinate this.

*References to Kosovo are without prejudice to positions on status. They are in line with United Nations Security Council Resolution 1244/1999 and the opinion by the International Court of Justice on the Kosovo declaration of independence.

Defensive medicine

The Executive Committee agreed that the draft CPME position paper on defensive medicine should be forwarded to members for discussion and decision at the April 2019 CPME meetings.

The draft position paper was presented by Dr Daiva Brogiene as Rapporteur for Defensive Medicine. She explained that the draft reflects the current evidence-base and concerns raised in the CPME membership's past discussions, as well as referencing previous CPME policies, e.g. on liability of doctors. It was proposed to make minor changes to the recommendations included in the paper, e.g. to phrase the objective of eliminating defensive medicine in a positive way. The amendment will be made ahead of the send-out of the draft position paper. CPME Secretariat will liaise with Dr Daiva Brogiene to this end.

International calendar

The Executive Committee took note of the CPME participation at forthcoming meetings of CPME members, European Medical Organisations and international partners.

Any other business

The Executive Committee approved the request of the Taipei Representative Office to Brussels to once again send a letter supporting Taiwan's invitation to the World Health Assembly (WHA) as an observer delegation in their own right to the relevant EU-level contacts, including DG SANTE Director General Anne Bucher. CPME sent a similar letter of support in 2018, however this was not successful.

Monitoring news

The European Court of Justice on public access to documents

The European Court of Justice ruled that the public must have access to information on emissions as well as information concerning the medium to long-term consequences of those emissions on the state of the environment. This also includes the effects of those emissions on non-targeted organisms.

The decision also included that public interest in accessing information on emissions into the environment is specifically to know what is, or foreseeably will be, released into the environment, and also to understand the way in which the environment could be affected by the emissions in question. The decision might also be interesting for the health sector.

The Commission Flash report on current measles outbreak in France and Ebola outbreak in DRC action on improving access to social protection

In 2018, there has been reported 36 measles related deaths in EU countries. At the moment vaccination coverage is below 95% in most countries, making the population extremely vulnerable to the disease. ECDC reports over 12 000 cases of measles in the EU/EEA over the past year, with the largest number of cases reported by FR, IT, EL, RO, UK, SK and DE.

France updated on the recently notified measles outbreak in the ski resort Val Thorens. Starting February 2019, there have been cases of measles possibly related to this outbreak reported by DK, UK and BE.

The Commission takes further action to ensure professionals can fully benefit from the Single Market

The Commission has taken further steps in infringement procedures against 26 Member States to ensure the full implementation of EU rules on the recognition of professional qualifications. The Professional Qualifications Directive ([Directive 2013/55/EU](#)) was modernised in 2013 and had to be transposed into national law by 18 January 2016. The Commission sent reasoned opinions regarding the non-compliance of national legislation and legal practice with EU rules on the recognition of [professional qualifications \(Directive 2005/36/EC\)](#) as amended by [Directive 2013/55/EU](#)). All Member States concerned have now two months to respond to the arguments put forward by the Commission.

Updates from the Turkish Medical Association

The second hearing of the trial against the members of the Council (2016-2018) of the Turkish Medical Association (TMA), was held in Ankara on 20 March 2019. Dr Jacques de Haller, Immediate Past President of the CPME, and Dr Otmar Kloiber, Secretary General of the WMA, attended the hearing in support of the Turkish Medical Association during these difficult times.

The session concluded with a suspension of the trial, for the Court to consider an objection to the motion submitted by the TMA lawyers stating that the Chief Public Prosecutor acted against the law. Another trial will be held on the 3rd of May.

The members of the Council are on trial because of the public statement issued on 24 January 2018 stressing that war is a public health concern that damages the environment and threatens the survival of society at large.
